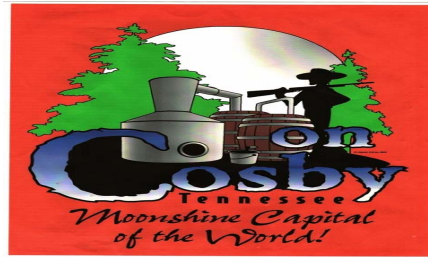


# "On Cosby" Moonshine Run



**Saturday, October 16, 2010**

**LOCATION:** Smoky Mountain Elementary School, 135 S Hwy 32, Cosby, TN 37722

**DIRECTIONS:** From KNOXVILLE – take I-40 East to exit 440 (Wilton Springs Road). Take 1<sup>st</sup> road to the right – Wilton Springs Road. At the end of Wilton Springs Road, turn left onto Cosby Hwy (Highway 32/Hwy321). Drive 7 miles. Smoky Mountain School is on the right.

From GATLINBURG: Turn at traffic light #3 onto Hwy 321 North. Follow Hwy 321 for 20 miles to intersection Hwy. 321 North and Hwy 32. Turn right onto Hwy. 32. Smoky Mountain School is 300 yards on the right.

From ASHEVILLE: take I-40 West to exit 443 (Foothills Parkway). Take Parkway to Hwy. 321. Turn left onto Hwy. 321, drive 3 miles. Smoky Mountain School is on the right.

**COURSE DESCRIPTION:** A fast 3.2 mile out and back course finishing on the walking track at Smoky Mountain School.

**REGISTRATION/FEE:** Runners may pre-register or sign up the morning of the race from 8:00 – 9:00 a.m. **Race start time is 9:00 a.m.** Pre-registration fee: \$15 (postmarked by October 10, 2010). Day of race registration \$20. Special sponsor contribution: \$20.

**AWARDS:** To the race winner, to the next 3 male and female runners, first Masters (40+) male and female runners, and first Grand Masters (50+) male and female runners, and first Veteran (60+) male and female runners. Other age awards three deep, male and female: x-9, 10-14, 15-19, 20-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, 70-79, 80+.

**T-SHIRTS:** Pre-registered runners receive shirts on race day. Race day folks receive shirts as supplies last.

**BENEFICIARY:** Cosby FCE (Family, Community, Education) Club, Inc., a non-profit organization.

The undersigned athlete (Athlete) on behalf of himself/herself and on behalf of Athletes personal representatives, assigns, heirs, executors, hereby fully and forever releases, waives, discharges and covenants not to sue the Cosby FCE Club, Inc, and/or The East Tennessee Foundation, USATF, Cocke County Board of Education, county agencies whose property and/or personnel are used and all other sponsoring or co-sponsoring companies or individuals related to the "On Cosby" Moonshine Run (collectively releases) from all liability to the Athlete and his/her personal representatives, assigns, heirs and executors, for all loss (es) or damages (s) and any and all claims or demands therefore, on account of injury to the Athlete or property or resulting in the death of the Athlete, whether caused by the active or passive negligence of all or any of the Releasees or otherwise, in connection with the Athletes participation in the "On Cosby" Moonshine Run. The Athlete represents and warrants that he/she is in good physical condition and is able to safely participate in the Run. The Athlete is fully aware of the risks and hazards inherent in participating in the Run and hereby elects to voluntarily compete in the Run knowing the risks associated with the Run. The Athlete hereby assumes all risks of loss (es), damages (s), or injury (ies) that may be sustained by him/her while participating in the Run. The Athlete agrees to the use of his/her name and photograph in broadcasts, newspapers, brochures and other media without compensation. The Athlete acknowledges that the entry fee is non-refundable and non-transferable. In the event the Run is delayed or prevented by reason of fire, threatened or actual strike, labor difficulty, work stoppage, insurrection war, public disaster, flood, unavoidable casualty, acts of God or the elements (including without limitation, hurricanes, tornadoes, earthquakes), or any other cause beyond the control of the Cosby FCE Club, Inc, and/or The East Tennessee Foundation, there shall be no refund of the entry fee or any other costs of the Athlete in the connection with the "On Cosby" Moonshine Run. The Athlete hereby grants to the medical director (s) of the Run and their agents, affiliates and designees access to all medical records (and physicians) as needed and authorizes medical treatment as needed. The Athlete warrants that all statements made herein are true and correct and understands that Releasees have relied on them in allowing Athlete to participate in the Run. IF ATHLETE IS UNDER AGE 18: The parent/guardian certifies that my son/daughter has my permission to participate in the Run. The parent/guardian has read the forgoing RELEASE AND WAIVER OF LIABILITY AGREEMENT (above) and by signing intentionally and voluntarily agrees to its terms and conditions. The parent/guardian further certifies that my son/daughter is in good physical condition and is able to safely participate in the Run. I hereby authorize medical treatment for him/her and grant access to my child's medical records as necessary.
